Single-Member Districts Bill Gets 1st House OK

Austin — The Texas House tentatively has approved, 112-7, a bill to require all major Texas cities to hold elections on the question of single-member city council districts.

HB 957 would require all cities over 600,000 to hold such elections. Small cities would have to hold elections on receipt of petition by 10 percent of the qualified voters in the last election.

House approval came Friday as members drifted away to attend to other matters.

The House needs a quorum—100 members — to 2conduct business. While vote tabulations reflected more than a quorum present late Friday, a head count showed only about 85 members present. Others were being voted by friends on the electronic house gadgetry.

With such scant attendance, the House took up the Senate-passed version of the bill reforming the state's penal code—one of the more important matters the legislature will consider this session.

However, after several members noted the lack of attendance, House Speaker Price Daniel Jr. accepted an adjournment motion.

In other action Friday, the House:

- Initially approved HB 611, 82-36, to give voters the option of retaining or rejecting daylight saving time.
- Initially approved HB 105, 68-50, authorizing commissioners courts—on approval of voters—to regulate the use of land lying outside the limits of incorporated towns.
- Tabled and killed SB 253, 75-53, which would have authorized lenders to charge 18 percent interest on loans between \$2500 and \$5000 to corporations. Opponents charged the bill was only a vehicle to raise interest rates for individuals by conference committee action.

- Initially approved HB 725, changing the status of domestic relations and juvenile courts to district courts of regular jurisdictions to be called family district courts. Harris County's five domestic relations courts and three juvenile courts would be affected by the administrative change, but would continue to specialize in family law.
- Initially approved HB 740, to authorize maternity leaves for school district employes.
